Bard's four-year tuition prepayment plan is available to incoming first-year students who do not receive financial aid toward tuition costs. The cost of tuition for each year of the student's four-year tenure is stabilized at the first-year amount.

The following conditions are applicable to this plan:

- For first-year students entering in the Fall 2024 semester, the \$32,807 per semester tuition charge is applicable for the four-year period including the Fall 2024 through the Spring 2028 semesters. Students who register beyond the Spring 2028 semester will be charged at the tuition rate effective for the semester in which they register.
- Allowance is made during the four-year period for one semester of academic leave for study abroad **or** one semester of personal or medical leave. Students who take such leaves and subsequently register beyond the Spring 2028 semester will be charged at the tuition rate effective for the semester in which they register. The \$32,807 pre-payment for the semester of leave is available for disbursement to the original payer; for academic leaves, it can be disbursed to the visiting school, upon request of the payer's choice. Students who are approved to take an academic leave will be charged an academic leave fee.
- The pre-payment plan is rescinded if the student takes more than one semester of leave (academic, personal, or medical), **or** if the student is dismissed or placed on a mandatory leave of absence by the Executive Committee, **or** required to take a conditional leave by the Office of the Dean of Students. If the student re-enrolls, the tuition rates effective at the time of registration will be applicable.
- The stabilized tuition charge is applicable for registrations up to and including 20 credits. Students who register for additional credits will be charged at the tuition rate effective for the semester in which they register for the additional credits.
- If a student withdraws from the College before completing four years of study, the excess credit balance on the student's account will be refunded to the payer.
- The plan applies to tuition only. Room, board, and fees are payable as billed each semester.
- Payment of \$262,456, the amount due for tuition costs from Fall 2024 through Spring 2028 at the current \$65,614 annual cost, is due in our office on or before June 20. We regret that payment extensions beyond this date are not available.
